1. The Homegrown Holiday Bazaar is on Saturday, December 3, 2022 from 10AM – 3PM at 2662 Mullet Hall Road, Johns Island.
2. All vehicles must be off property no later than 9:45AM, no exceptions.
3. Breakdown time is between 3PM – 4PM.
4. Booths must remain open from 10AM – 3PM Saturday. All vendors must keep these hours. Early dismissal will not be permitted due to the safety of our guests.
5. All completed registration forms and payment must be in no later than 4PM on November 23, 2022. No late registrations will be approved.
6. Spaces will be assigned to each vendor only after completed registration form and payment are received. We reserve the right to limit the number of vendors in each type of category. If we cannot accommodate you, you will be notified immediately and we will return your vendor registration fee. Registrations and payment must be submitted by 4PM on November 23, 2022 to be considered.
7. Goods Vendors will be provided a 10x10' space. No electricity or water is provided.
8. Vendors must provide their own tents, tables, chairs and anything else needed for their designated space.
9. Vendors are responsible for securing tents and stands to the ground in case of inclement weather. Weights of 25lbs+ are recommend per tent leg.
10. No solicitation is permitted without vendor space rental.
11. Vendors are responsible for cleaning up their stations and hauling their trash away.
12. Food vendors must annually provide required documents with registration form and must be compliant with all SCDA/DHEC regulations while at the market. Anyone cooking on site must be provide proof of product liability insurance.
13. Parking for vendors will be in a designed area upon arrival. No vehicles allowed at vendor tent sites after set up concludes at 9:45AM.
14. Homegrown Holiday Bazaar reserves the right to inspect any and all items and if deemed inappropriate, items will be asked to be removed.
15. Homegrown Holiday Bazaar will not assume responsibility for damage, loss or injury that may occur to the vendor or the vendor's belongings.
16. Please have a copy of your sales tax license available (if applicable).
17. NO RAIN DATE – The bazaar is held rain or shine. NO REFUNDS WILL BE GIVEN.
18. Cancellations: One week written notice must be given if vendor needs to cancel for a refund. Refunds will not be granted if less than one week.
